Briefing on Task Force from Cat (Transportation)

- Task Force led by Transportation will be planning around Advanced Rapid Transit (ART) corridors to create Transit Oriented Development (TOD) framework and policy
 - This will align with the TWG's work, which is specific to housing affordability in the ART corridor area
 - Goal among TWG members is consensus on recommendations, informed by previous plans and policies

Briefing on past TOD work from Christine (VIA)

- Background from VIA:
 - VIA and COSA have been working on TOD since 2009, but never took action to submit amendments during Unified Development Code (UDC) amendment cycle
 - In 2018, VIA received funding from the FTA for TOD pilot planning to develop zoning code, provided VIA partnered with COSA
 - VIA would do legwork, while City would have public engagement concurrently through SA Tomorrow
 - Ready to move forward to UDC amendment cycle in 2020, but delayed due to COVID.
 - VIA has a fairly complete first draft, but no meaningful public engagement yet
 - Deliverables: code with templates; layman's developer guide for developers and other municipalities interested in similar TOD projects; north-south line - typologies of station areas along that corridor, would likely be applicable to most stations
 - Once list of typologies more complete, may also apply to east/west line (received funding in 2021 to examine east/west line)
 - Communities Grant what does equitable TOD look like along ART corridor?
 - Two elements: street (curb-to-curb what to make transit function operate) and back-of-curb
 - Thus far, three different prototypes for back-of-curb station areas - small, medium, and large)

- Depth of lot on transit corridor much shallower than in other cities (low-scale development abutting transit corridor) ensure address need for balance, transition zone
- Note in Chat regarding existing language in UDC: Table 506-3 Street Design Standards: Footnote 2 - Additional right-ofway and alternate design standards may be required on designated advanced rapid transit corridors as identified in the Major Thoroughfare Plan.

Questions and Comments

- Back-of-curb (as well as curb-to-curb) important to effective TOD policy question to VIA staff on how past code and station area typologies were developed
 - VIA has consultant to assist, but haven't been able to do public engagement yet
 - Consultants and staff available for questions about code, effect of potential changes
 - Typologies have narrow focus along corridor to ensure address individual neighborhood character
- Question to staff on how community engagement will take place
 - Able City on consulting team; VIA staff can pass along existing engagement plan
 - Staff and others to create plan to keep public informed and engaged

Closing Thoughts and Goals

- · Goals to move forward
 - o Ensure existing affordable housing remains affordable
 - Create opportunities for new affordable housing along ART line
 - Create neighborhood typologies that can be applied across ART line(s) and city
- Details on Task Force from Cat (Transportation)
 - Task force will be a mix of technical and neighborhood members, and they'll work on entire TOD policy
 - o Task force and TWG will ensure goals are aligned
 - Will determine where to place TOD zoning
 - Website will be available with updates
